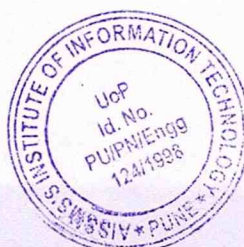
- Applications are invited for the Supernumerary Quota - PIO-OCI/CIWGC/FN seats for following First year B.Tech. Engineering courses.
