

New Delhi, the 18th July, 2025

S.O. 3391 (E).—Whereas by the notification of the Government of India in the Official Gazette, S.O. 1905 Dated 24/04/2025, published in Gazette of India, Extraordinary, issued under sub-section (1) of section 3A of the National Highway Act, 1956 (the said Act), the Central Government declared its intention to acquire the land for the said notification for building (widening/improving/lining, etc.) maintainance of the said stretch of land from Km. 41.369 to Km. 83.550 (S/O Baramati) of MAHARASHTRA

And whereas the substance of the said notification has been published in the Official Gazette (English) both dated 24/04/2025 under sub-section (3) of the said Act;

And whereas the Competent Authority has received objections (3) of the said land and submitted its report to the Central Government;

Now, therefore, upon receipt of the said report of the Competent Authority, notified by the sub-section (1) of section 3D of the said Act, the Central Government hereby declares that the said stretch of land is required for the said purpose.


And further, in pursuance of sub-section (2) of section 3D of the said Act, the Central Government hereby declares that on publication of this notification in the Official Gazette, the land shall vest absolutely in the Central Government free from all encumbrances.
